Intended Use	The devices are used to assist caregivers in showering routines, cleaning, toileting, changing clothes and moving conscious patients that have reduced or little muscular function safely and comfortably.  The devices are mobile to allow transport to and from the bathroom area and transfers and movement within the bathroom area. The devices allow the patient physical support during showering, washing, drying, toileting and dressing in a safe and comfortable sitting position. The armrests will give support for sitting up, and swivel away for easy sideway transfers. All bathroom safety devices have a maximum safe working load as indicated on the labels and in the IFU. All devices can be tailored to the patient's and caregivers needs with the use of accessories.  The swimming pool hoist chair may be used as described above and for the use of physical therapy sessions or relaxation in a swimming pool environment.  Some variants of the devices, including the combi chair tilt are equipped with keyhole shaped seating surfaces. This allows the user to maneuver the device over a toilet for toileting activities. The devices equipped with a rail underneath the seating surface allow the use of a bedpan for the same purpose.
